CVT PROVIDES DIRECT MENTAL HEALTH COUNSELING SERVICES TO REFUGEE TORTURE SURVIVORS IN THE DADAAB REFUGEE CAMPS IN KENYA, AND PROVIDES BOTH COUNSELING AND PHYSIOTHERAPY SERVICES TO IRAQI AND SYRIAN REFUGEE TORTURE SURVIVORS AND THEIR FAMILIES IN JORDAN. IN 2012, CVT LAUNCHED TWO NEW DIRECT SERVICES PROGRAMS, ONE IN REFUGEE CAMPS IN NORTHERN ETHIOPIA TO PROVIDE MENTAL HEALTH SERVICES TO ERITREAN REFUGEES, AND ONE IN NAIROBI, KENYA, TREATING URBAN REFUGEE TORTURE SURVIVORS FROM THROUGHOUT EAST AFRICA. THE TWIN CITIES BASED HEALING PROGRAM IS A UNIQUE AND INTEGRATED PROGRAM SERVING 250 CLIENTS PER YEAR IN A MULTIDISCIPLINARY CARE AND TREATMENT PROGRAM THAT INVOLVES THE PROFESSIONS OF MEDICINE, PSYCHIATRY, PSYCHOLOGY, SOCIAL WORK, NURSING, MASSAGE THERAPY AND PHYSICAL THERAPY.
